General learning at the event

- Molina and CA Health and Wellness both have wraparound services
- They compete and work together
- An additional 76,000 residents now have healthcare
- CA Health and Wellness is the county health plan – department of healthcare services
- Imperial is a 2 plan model county
- Three types of coverage
 - Commercial/private
 - Subsidized – Covered CA
 - Medi-cal
- Eligibility:
 - Depends on category
 - Child, Senior etc
 - Medi-cal Expansion as of 1/1/2014
 - For Childless adults ages 19-64 under 138% FPL
- Health plans are paid differently depending on category
- Many programs and offerings are under-utilized in both plans
- Each have the goal of a healthier community
